# Ohio Historical Records Advisory Board Final Report, Grant NAR15-RC-10233-15

This is an update on the activities of the Ohio Historical Records Advisory Board (OHRAB) between January 1, 2015 and March 31, 2016, as funded by a grant of \$23,361.

## **Board Personnel**

On April 1, 2015, the following members left the board due to term limits, per OHRAB's bylaws:

On October 30, 2015 board member Heidi Samuel resigned. The board will consider candidates to replace her in 2016.

Melva Kleineick, who had been providing administrative support for the board, resigned as an administrative assistant at the Ohio History Connection in November 2015. Her replacement, Theresa Hopewood, assumed her duties with the board.

#### **Board Meetings**

The board met on January 30, 2015 at the Ohio History Connection in Columbus. The board discussed its participation in the 2015 Statehood Day advocacy event. Other topics of discussion included: OHRAB's regrant program; the board's 2016 grant application; and improving the board's outreach and advocacy efforts.

The board met on April 24, 2015 at the Ohio History Connection in Columbus. The board received updates on the regrant program and the board's History Day award. Members also reviewed the board's participation in the Ohio History Connection's Statehood Day and discussed the National Historical Publications and Records Commission's and Council of State Archivist's SHRAB award.

The board met on July 17, 2015 at the Ohio History Connection in Columbus. Members discussed the board's support of the Ohio Electronic Records Committee's fall workshop and decided to offer travel scholarships to the workshop for library science and public history graduate students. The board also discussed New Jersey's Caucus Archival Projects Evaluation Service (CAPES) program and whether something like that could be replicated in Ohio to provide smaller repositories with assistance from professional archivists in evaluating, organizing and preserving their archival materials.

The board met on October 30, 2015 at the Ohio History Connection in Columbus. The board elected a chair and vice-chair. The board also discussed hosting a meeting to facilitate collaboration on potential grant projects and a survey of archival institutions to gauge their needs.

#### Statehood Day

The 2015 Statehood Day advocacy event was held at the Ohio Statehouse on March 4. Six members of OHRAB attended the event which was held to promote and advocate on behalf of Ohio history. Copies of OHRAB's brochures were distributed to attendees and legislators.

#### History Day

On April 25, 2015 OHRAB presented two awards for the best use of Ohio's historical records in a History Day project. John Victor Pan was recognized for his website "John D. Rockefeller: Industrial and Philanthropic Leader." Winning the junior category, Pan used government documents, photographs, articles and political cartoons in his website to better understand the varying perspectives through which people viewed John D. Rockefeller. The project website is located at http://71811685.nhd.weebly.com.

Jeremy Gimbel won the senior category for his website "Rabbi Arthur J. Lelyveld: A Man Obsessed with Peace." Gimbel wove photographs, books, policies, and bulletins from the archives at Fairmount Temple in Cleveland, Ohio, along with images, maps and letters from the digital archives at the University of Southern Mississippi into his telling of how Rabbi Lelyveld's efforts in championing civil rights and global equality impacted

both the larger national story and the history of his own congregation in Cleveland. Gimbel's project website is located at http://56292800.nhd.weebly.com.

#### Archives Achievement Award

In October OHRAB awarded its Achievement Award during Archives Month. The award recognizes significant accomplishments in preserving and improving access to historical records in any format by an Ohio archival institution. The board chose the Delaware County Records Center and the Kelleys Island Historical Association as the 2015 recipients. The Delaware County Records Center was recognized for its devotion to the care, preservation, and accessibility of county records through continual modernization of processes and dedication to providing convenient public access to the records in its care. The Kelleys Island Historical Association was honored for its efforts in implementing archival accession, processing, and cataloging procedures; increasing the accessibility of its collections through the creation and publishing of its inventory; and fostering research through new initiatives.

## OHRAB Regrants Presentation

At the fall Ohio Local History Alliance and Society of Ohio Archivists Conference on October 2, OHRAB state coordinator Fred Previts gave a presentation on OHRAB's regrant program as part of a session discussing grant opportunities. This presentation gave an overview of the grant program and discussed the application process.

## OhioERC Workshop

Through its 2015 operating grant OHRAB provided support to the Ohio Electronic Records Committee Workshop held on October 28, 2015. "Your Seat at the Purchasing Table: A Records Management Point of View" focused on purchasing a records management system and how to navigate the process as a records manager. It was a half-day workshop that was offered twice that day and there were 34 attendees. OHRAB provided USB drives loaded with the workshop slides and handouts to attendees (OHRAB also offered travel scholarships to graduate students in Ohio public history and library science programs but there were no applicants).

## **Grant Review**

In December board members reviewed and provided comments on a NHPRC Digital Dissemination of Archival Collections grant application from an Ohio institution.

#### Exploration on Fostering NHPRC Grant Submissions

The board received an extension on its 2015 grant to host a meeting of OHRAB members and county archivists. The meeting was intended to generate ideas for possible NHPRC grant applications from the counties. On January 14, 2016 ten county archivists and records managers attended the meeting on-site at the Ohio History Connection while two others participated by phone. Six OHRAB members were in attendance. The meeting generated some possible ideas for a 2017 grant application.

On March 11 a follow-up meeting was held at the Ohio History Connection. Ten archivists representing eight counties attended. Two members of OHRAB and an Ohio

History Connection staff member were also in attendance. At this meeting the archivists chose three record series to focus on and also discussed the digitization and indexing process.

## Digitization Workshops

The board has had to postpone the public digitization workshops it was to hold in the fall. This was due to renovations and other scheduling conflicts with the libraries that are hosting them. The workshops are tentatively scheduled for later in 2016.

#### Regrant Program

As part of its 2015 NHPRC grant, OHRAB received \$15,457 for a regrant program. In early January 2015 OHRAB's Regrant Committee announced the regrant opportunity through Ohio archives and records management listservs and networks. In response to the grant announcement, OHRAB received 20 applications requesting a total of \$29,465.

OHRAB's Regrant Committee reviewed the applications and chose the recipients via a phone conference. Eleven institutions were chosen. Members of OHRAB worked one-on-one with the grant recipients to provide oversight and guidance for the projects.

Collectively the regrant projects processed more than 90 cubic feet of records and made publicly accessible more than 1,500 digital images. In addition, 119 audio reel-to-reel tapes have been digitized and are available to the public and 9,552 microfilm frames created and made available for public use.
